Final Report

The Meeting of Standing Committee on Economic and Sustainable Development was held on May 16-17, 2023 in Manama, Kingdom of Bahrain.

The Meeting hosted by Council of Representatives of the Kingdom of Bahrain and parliamentary delegations from following 21 member countries participate in the Meeting:

Bahrain, Bangladesh, China, Cyprus, India, Indonesia, Iran, Iraq, Jordan, Kirgizstan, Kuwait, Maldives, Pakistan, Palestine, Qatar, Russia, Saudi Arabia, Syria, Thailand, Turkiye and UAE. ([Attachment I](#))

1. Adoption of the Agenda

The Member Parliaments unanimously adopted the Draft Agenda. Agenda is attached. ([Attachment V](#))

2. Election of the Bureau:

The following member parliaments were elected:

- Bahrain, Chairman
- Jordan, Vice-Chair
- Kirgizstan, Rapporteur

3. Opening remarks by the Chairman

The Chair requested heads of participating delegations to present their short opening statements. Some delegations in addition to their general remarks referred to few difficulties in bilateral relations as well.

4. Report of the APA Secretary General

APA Secretary General reported on major developments of the draft Resolutions of the Standing Committee and outlined the APA Reform and Revitalization Process. (Attachment VI)

5. Consideration of the Draft Resolutions:

The representative of APA Secretariat requested participants to take note of the following main principles while address amendments to draft resolutions:

- Only amended paras will be debated.
- Authors of amendments should be present at the meeting.
- Titles of Draft Resolutions are not to be amended.

There were 8 Draft resolutions to be considered by the Standing Committee. Two of these Draft Resolutions (I.e. Roadmap for Green Finance and Asian Climate Financial Initiative) which were initiated by delegation of Russian Federation were merged and a new draft resolution titled: "Asian Climate Financial Initiative" was offered to the Committee. Thus amendments to 7 draft resolutions were considered and adopted according.

Due to the long texts of some draft resolutions, the head of delegation of Bahrain proposed that APA Secretariat be tasked to shorten these documents while keeping the main topics intact. The proposal was approved by the meeting.

6. Report of the Secretariat on the following Working Groups:

- Green Funding
- Asian Energy Market
- Water Crisis

The representative of the APA Secretariat stated that all the above Working Groups have held their respective meetings and by formulating the issues and topics of interests into separate draft resolutions, have exhausted their mandates. The APA Secretariat thus proposed the termination of their activities. This proposal was approved by the Standing Committee. From now on, participants interested in the activities of the above mentioned Working Groups may refer themselves to the contents of relevant draft resolutions and update them with their views accordingly.

7. Closing Session, Adoption of the Final Report.

Closing Session:

The delegation of Palestine made the following closing statement:

- 1- Demanding that Israel stop confiscating Palestine water.

- 2- Stop the piracy of Palestinian money and tax revenue and demand that Israel release the funds it has been holding for four years (clearance fund: Palestinian Rights in the share of taxes.)
- 3- Stop the Israel obstructions causing an impact on the mobility of imports, exports and tourism.

The APA Secretary General made a brief statement and underlined that the pre-requisite for the success and active involvement in the international and international regional affairs for any international organization solely depends on political will and commitments of its member countries. He noted that there will be a meeting of Standing Committee on Budget and Planning in Tehran in July 2023. The dates for Standing Committees on Social/Cultural and Political Affairs are yet to be announced by Azerbaijan and Iraq. The Candidacy for APA President is also to be decided by member Parliaments for 2024-5.

Chairman of the meeting expressed his deep appreciation to all participants for full support of the success of the meeting. He also commended the APA Secretariat for its professional work.

Final Report:

The Chairman stated that the final report of the meeting will be prepared and sent to all participants by APA Secretariat in few days time.

8. Any Other Matters

No issue was raised.

The participants will be invited to adopt the draft Agenda.

2. Election of the Bureau

Participants are encouraged to volunteer for the positions of Vice-Chair and Rapporteur of the meeting.

3. Opening Remarks by the Chairperson

The Chair will present his opening remarks.

4. Report of the APA Secretary General

APA Secretary General will report on the work of the Standing Committee and outline his views on the draft resolutions to be considered by the meeting.

5. Consideration of the Draft Resolutions:

Under this item, the Chair will introduce the draft resolutions before the Committee and will invite authors of the amendments to present their proposed texts. The Chair will rule on each amendment and the draft resolution in question is adopted.

On Draft Resolutions: "Adopting a Road Map Providing for Measures to Stimulate Green Finance" and "Asian Climate Financial Initiative" the APA Secretariat requested the Russian Delegation, as the author of these documents to merge them and provide us with one text.

6. Report by Chair of the Working Group on Green Funding

The delegation of Russia presented a report on Green Funding during the virtual meeting of this Standing Committee on 20 May 2021 in Bahrain. The Chair requested the report to be sent to the APA Secretariat for circulation. The Secretariat is yet to receive this report.

7. Report by Chair of the Working Group on Integrated Asian Energy Market

The Chair of the previous virtual meeting of the Standing Committee ruled that due to the absent of delegation of Kuwait this report be presented to the next Standing Committee meeting.

8. Report by Chair of the Working Group on Water Crisis

The Chair of this Working Group presented its report to the previous meeting in Manama in 2021. The report was circulated to all members. Interested members have responded to this report and thus the WG has exhausted its mandate. Participants may raise their complementary views within the context of relevant draft resolutions as we proceed.

9. Adoption of the Final Report

The APA Secretariat will prepare Final Report of the meeting for consideration and approval of the participants.

10. Any Other Matters

Participants will have the possibility to introduce any other issue of their interest not covered on the Agenda.

Report of the APA Secretary General

**Mr. Chairman,
Distinguished Delegate,
Dear Colleagues,**

I have the honor to welcome you all to the first APA Standing Committee meeting in year 2023. At the same time, allow me to seize this opportunity to thank the Council of Representative of the Kingdom of Bahrain for accepting to take over the APA Vice-Presidency and host as the chair of this important meeting in the magnificent capital city of Manama.

As you may recall, at the virtual meeting of the Committee held by the Kingdom of Bahrain in May 2021, six draft resolutions out of eight, were considered and adopted by consensus. At this meeting the draft resolution on "Financial Affairs: Ensuring Efforts for Economic Growth" and "Water and Sanitation in Asia for All", were deferred to the next SC meeting for further consideration. Furthermore, the Russian delegation as the author of the draft resolution "Adopting a Roadmap Providing for Measures to Stimulate Green Finance" and "Asian Climate Financial Initiative" has merged the two draft Resolutions and tabled it as a new draft resolution to this meeting. Therefore, today we have 7 draft resolutions for your consideration.

Dear Colleagues,
Distinguished Delegate,

Since I took office as the APA Secretary General, I was preoccupied with APA reform process, as I firmly believe that APA as a dynamic organization ought to constantly work out a revitalization program and put it at the top of its Agenda. In this endeavor, we managed to establish the Working Group on Statutory Documents in 2018 in Rize, Turkiye to give an impetus to this process.

As an extremely important process, this issue was also pinpointed by the APA President, H.E. Professor SENTOP, during the 13th APA Plenary in January, 2023 in Antalya, Turkiye. At this meeting we noticed that the APA president specifically referred to the need for application of some changes in the current structure, regulations as well as reinforcing the Institutional efficiency and Payment Contribution if we are seeking to transform the APA into an important Parliamentary Forum. To make such structural visions come true, the APA President, proposed Expert Groups to be established on the basis of regional distribution.

In light of the foregoing, I would like to categorize this reform plan into the following two main groups of issue:

I. APA structure and regulations

II. APA working method

As regards the first category, we have already established the WG on Statutory Documents to revisit and update the Basic Documents of the organization. Therefore, all the new suggestions and amendments to the APA institution, structure, objectives and regulations are to be covered by the WG. The WG held its First Session in December 2021 in Urgup, Turkiye and the Second Session of the WG is scheduled for July 03-5 in Iran.

Regarding the Second category, as you are aware since the establishment of our Organization in 2006, APA followed the customary procedure (Method of Work) established by international organization, particularly UN&IPU, to deal with the entrusted job when the Standing Committees, Executive Council, Plenary and the Bureau meets at scheduled intervals.

As the time passes, it seems that we need to change or introduce new effective and applicable procedures in order to streamline and accelerate the process of the adoption of the documents.

With this mindset, I sent you a letter inviting you to contribute to a brain storming session to discuss this important topic. In fact, the idea behind this innovation session was to set precedence in our strategy to continue holding such meetings in future if we are eager to witness specific changes needed to be made in the work of Standing Committees. I am quite confident that with some effective changes in the method of the work of the APA meetings, we shall certainly do our job in amore productive and fruitful way.

Following items are some of the suggested reform procedures applicable to the work of the Standing Committees:

- Presentation of a brief report by the national parliaments on the implementation of the recommendations cited in the resolutions by the APA delegations at the SC meeting.
- Changing the current procedure regarding the drafting exercise and to differentiate among the draft resolutions as redundant, outdated or relevant with a vision tuned with the reform initiatives.
- Encouraging delegations to submit and table new draft resolutions pertinent to the work of SC with due respect to the current global developments
- Adoption of new theme/subject for the new draft resolutions to be submitted to the concerned Standing Committees for consideration.
- Establishing procedure for the removal of the outdated resolutions from the agenda of the SC.

In conclusion, I would like to underline that the prerequisite for the success and active involvement in the international and inter-regional affairs of an international organization solely depends on political will and commitments of the member countries. Active participation in all events and gatherings, financial contribution to the work of the organization, implementation of the recommendation and decisions, commitments to the charter and goals of the organization, taking up the leadership and high posts and hosting the meetings, are amongst other key factors leading to the success of any international organization.
