#### 7- Any Other Matters:

**1-**Based on the decision of the APA Bureau, a meeting of the Working Group on Statutory Documents was held on the sidelines of the Standing Committee on Political Affairs.

APA Secretariat presented a non-paper on Article 5 of the Charter and Rule 15 of the Rules of Procedure.

After exchange of views on the text of the non-paper, the meeting supported the text of the proposed non-paper and stressed that there will be only four Standing Committees. 2. The second meeting of the APA Committee on Palestine was held on the sidelines of the APA Standing Committee on Political Affairs in Baghdad on January 12, 2025.

This meeting was opened by the Chair of the Meeting, Mr. Ali Faysal, Head of Delegation of Palestine, who welcome the participants and asked them to observe one minute silence in memory of the martyrdom of the Palestinian People . Then, he made his statement on the latest situation in Gaza Strip.

The APA Secretary General also made an address on the tragic and painful situation of the people of Gaza and Lebanon.

Participants also made their remarks on the catastrophic situation of the Palestinian people in Gaza and expressed that a lasting and sustained ceasefire would be established in the region.

The draft resolution on "Asian Parliament's unwavering support for Palestinian People" was extensively by participants and several major amendments, new paragraphs, etc. were introduced into the text aiming at reinforcing the support for the Palestinian people. This draft resolution was unanimously adopted .( a special opinion of the Russian Delegation on this draft resolution was circulated among the participants,)

Mr. Secretary-General of the Asian Parliamentary Assembly

Distinguished members of the Asian Parliamentary Assembly

Ladies and gentlemen, all respectful participants.

Peace, mercy and blessings of Allah be upon you

Thank you for joining us today

We welcome you to your second country, Iraq

The meeting of the Standing Committee on Political Affairs of the Asian Parliamentary Assembly comes as we are on the verge of a dangerous phase sweeping the Middle East, a phase in which the basic principles and concepts of international charters and norms such as sovereignty, territorial integrity, the right to self-determination, the right to live in dignity, humanitarian laws, international humanitarian law, the responsibility to protect, multilateral cooperation and the laws of war are being ignored, amidst an ambiguous international system based on double standards and interests and lacking in providing international protection and justice in order to maintain international peace and security. Therefore, it has become very important to work seriously to reform the international system and reconsider its effectiveness in a way that serves the interests of future generations and achieves the goals of sustainable development.

What is happening in Palestine today of massacres and genocide committed by the brutal Zionist entity against innocent civilians is a dangerous precedent that has no precedent in the modern era. The killing of thousands of children and women, the bombing of hospitals and shelters for the displaced, the cutting off of humanitarian aid, the killing of relief workers, mass starvation and the freezing of young children in the bitter cold are scenes that make us all face a great humanitarian responsibility... and due to the lack of a deterrent in all of this and by extension its brutality and violations, we have witnessed the Zionist entity's aggression against beloved Lebanon and its destruction of buildings, the killing of defenseless innocents and the ingenuity of war crimes such as the use of technology to carry out explosives and destroy infrastructure and the displacement of civilians, children and women. The Zionist entity's incursion into the Syrian Golan also warns of a serious threat that may drown the region in conflicts and battlefields that may burn everything if this brutal aggression is not stopped immediately and without compromise as an attempt to establish the foundations of international peace. Hence, Iraq, the government and people, with all its components and spectrums, and the directives of its supreme religious authority, confirm its firm position to support the Palestinian people and the Lebanese people and provide the maximum possible material and moral support. We also call on the international community, its legal institutions and international organizations to work seriously and effectively to immediately stop the war on Gaza, curb the brutal Zionist aggression, implement the binding decision of the International Court of Justice declaring the Zionist presence on Palestinian lands illegitimate and thwart its malicious plans aimed at dividing the region. We should not be satisfied with slogans of condemnation and denunciation, but rather there must be responsible positions and practical steps towards what is happening in the region to avoid a potential regional war.

With regard to the situation in Syria, Iraq confirms its keenness on the integrity of Syrian lands, the right of the Syrian people to self-determination, the unity of its lands, the preservation of its sanctities and its independence away from foreign interference in order to achieve stability, prosperity and living with dignity away from extremism, violence and tearing apart the Syrian ranks.

#### Dear brothers,

You meet today in Iraq of peace... Iraq of civilization, science and knowledge... Iraq of heroism, glory and pride... Iraq of steadfastness and challenge... This Iraq that faced the most difficult circumstances and the most severe wars, but every time it proved to the whole world that it is like a phoenix rising from its ashes safe and sound... It gets sick but does not die thanks to the efforts of its sons and its heroic and valiant army, the cohesion of its unity and the wisdom of its supreme and wise religious authority...

Iraq today is an axis of convergence, cooperation and peace... an axis of construction, development and prosperity... Iraq has taken great steps to achieve security, victory over terrorism and restore life to destroyed cities through comprehensive plans for construction, reconstruction and development. Today we are witnessing the implementation of major urban, economic and development projects and we are striving to achieve the goals of sustainable development.

The legislative authority in Iraq works side by side with the executive authority and supports the efforts of the Iraqi government in completing its government program and commends the efforts made by the Iraqi Prime Minister, Eng. Mohammed Shia al-Sudan, to maintain the security, stability and unity of Iraq through a successful and moderate foreign policy..

#### Dear Colleagues,

The tragic situation that is still continuing with no mercy.

Under such circumstances, APA, as part of its mandate in the context of parliamentary approaches has strived to make every possible effort needed in the face of continued acts of genocide in Gaza and is quite ready as a key parliamentary platform in the vast Continent of Asia for the enhancement of close cooperation in an attempt to intensify its unsparing support for a lasting and sustainable ceasefire in order to put an end to the alarming massacre of the innocent people in the blockaded enclave by the Apartheid regime of Israel.

## Opening Ceremony of the Asian Parliamentary Assembly, Standing Committee on Political Affairs Baghdad, Iraq, 11-12 January 2025

### Speech of the Representative of the APA President and Head of the delegation of Azerbaijan to the APA, Dr. Rizvan Nathiyev

His Excellency Mr. Mahmoud Al-Mashhadarii, Distinguished APA Secretary General Dr. Majidii, Honorable Members of the Parliaments, Dear ladies and gentlemen,

It is a great honor for me to address the Opening Ceremony of the Standing Committee on Political Affairs of the Asian Parliamentary Assembly as the Representative of the APA President and the head of the Azerbaijani delegation.

I am delighted to convey best greetings from Hier Excellency Professor Sahiba Gafarova, President of the APA and Speaker of the Mational Assembly of Azerbaijan.

I extend my heartfelt gratitude and appreciation to the Council of Representatives of Iraq and his Speaker His Excellency Wir. Wathmoud Al-Mashhadani, and also Dr. Jabbar Al-Kinanii for the exceptional hospitality and meticulous arrangements and the successful organization of this meeting.

Furthermore, I sincerely thank His Excellency Dr. Mohammad Reza Majidi and the APA Secretariat for their dedicated efforts in enhancing the organization's activities.

The Asian Parliamentary Assembly is an essential platform for coordinating multilateral efforts and enhancing parliamentary diplomacy to foster peace and security. Alongside the developments and adhievements in various fields in Asia, serious challenges, inter alia humanitarian crises, regional conflicts, armed clashes continue to negatively impact the Asian region and beyond.

We are deeply concerned about the escalation of tension in the Middle East. To our great regret, we are witnessing that the geography of military actions is expanding. Unfortunately, one of the most pressing problems in the region is the situation in Gazza. We remain deeply concerned with the continued tension in Gazza. We support efforts to reduce tensions and find a political solution, both in Gaza and in Lebanon.



The resolution of Palestinian-Israeli relations and the establishment of an independent Palestinian state have always been the focus of the attention of Azerbaijani Side. As has been repeatedly stated at various international forums, Azerbaijan's position is unequivocal: Azerbaijan supports a two-state solution to the Israeli-Palestinian conflict: an independent Palestinian State must be established and East Jerusalem should be its capital.

The severe tragedy in Gaza must be urgently brought to an end, the war halted, and all outstanding issues addressed through peaceful negotiations.

We will continue to support the efforts to achieve a just, lasting, and peaceful solution to the issue of Palestine in line with fundamental norms and principles of international law.

#### Dear colleagues,

The Republic of Azerbaijan is also following the developments taking place in Syria. Azerbaijan supports the territorial integrity and sovereignty of Syria and hopes that the problems will be resolved following the will of the Syrian people as well as through domestic political dialogue. It is absolutely essential to restore peace and stability in the country and end the civil confrontation.

Azerbaijan, together with the brotherly Türkiye and other like-minded partners, is ready to contribute to the resolution of the humanitarian problems faced by the Syrian people. In December 2024, Azerbaijan dispatched a humanitarian aid convoy from Baku comprising 10 trucks loaded with 200 tons of various food and grocery products.

In addition, Azerbaijan will also extend necessary support to the new government on the diplomatic arena. To this end Azerbaijan is planning to reopen its embassy in Damascus. We are hopeful that bilateral relations between Azerbaijan and Syria will be restored and cooperation will develop based on mutual friendship and partnership.

Azerbaijan has declared its readiness to provide potential support in Syria's reconstruction process. Azerbaijan's experience in restoration and reconstruction, gained after liberating its territories from occupation, could be utilized in Syria's recovery process.

#### Dear colleagues,

For the first time since decades, de-facto peace is established between Armenia and Azerbaijan, stability has been achieved on the ground. The end of illegal 30 yearlong occupation created substantially new political situation in the South Caucasus based on the international law.



The President of Azerbaijan, Mr. Ilham Aliyev, took the initiative to propose a peace treaty and normalize relations with Armenia. Over the past years, 15 of the 17 essential points of the peace agreement already agreed upon. A commission for border delimitation and demarcation between Azerbaijan and Armenia has been established and is currently continuing its work. Demarcation has already been completed along a small part of the provisional state border.

For full normalization, however, Armenia must make constitutional changes to renounce its territorial claims against Azerbaijan.

The formerly occupied territories of Azerbaijan, seven cities and more than 300 villages have suffered unprecedented destruction. The cultural heritage, including almost all the Mosques were destroyed or desecrated. The city of Aghdam, left in ruins, is tragically called the "Hiroshima of the Caucasus." It is also crucial to address the fate of around 4,000 Azerbaijanis who went missing during the First Karabakh War with Armenia in the early 1990s.

As a result of 30 years occupation, Azerbaijan is now one of the most heavily mined countries in the world. An estimated 1.5 million landmines pose a serious threat to some 12 per cent of my country's territory. Despite these challenges 700,000 Azerbaijanis who were forcibly displaced and subjected to ethnic cleansing, are still waiting to return to their homes in the Karabakh and Eastern Zangazur, in safety and with dignity.

Meanwhile, around 300,000 Azerbaijani refugees, who were forcibly expelled from Armenia in the late 1980s before the collapse of the Soviet Union, remain displaced from their ancestral homes. Despite repeated appeals by the West Azerbaijani Community to engage in dialogue and ensure their safe and dignified return, the Armenian government denies them the fundamental right of return, enshrined in various international human rights instruments.

#### Dear colleagues,

As multi-polarity rises and multilateralism faces new challenges, Asia must respond with unity, cooperation, and shared responsibility. In this context, at the end of my speech, I would like to inform about the activities of Azerbaijan in the two organizations consisting of the Asian countries. D-8, Developing Eight Organization for Economic Cooperation and CICA - Conference on Interaction and Confidence-Building Measures in Asia.



In December 2024, at the Summit of the Developing Eight, Organization for Economic Cooperation, held in Cairo, Egypt, the Republic of Azerbaijan was elected as a member of the D-8. The foundation of the organization was laid on the initiative of Türkiye in 1996 with the cooperation of Bangladesh, Egypt, Indonesia, Iran, Malaysia, Nigeria and Pakistan.

The Organization for Economic Cooperation D-8 unites now nine Muslim countries on three continents with a population of over 1.2 billion people. The Gross Domestic Product of the member states of the D-8 exceeds \$4 trillion.

The D-8 membership of Azerbaijan will also be a great asset in promoting Islamic solidarity. Azerbaijan has always played the role of a bridge between East and West throughout its history. In this context, the contribution to security and stability in a vast region of Asia, as well as to the development of trade, transport and communications are of paramount importance.

Dear colleagues,

At the Ministerial Council meeting of the Conference on Interaction and Confidence-Building Measures in Asia, called CICA, held also in December 2024, the Chairmanship of the Conference for 2024-2026 was handed over to Azerbaijan. The idea of convening CICA was proposed by the Republic Kazakhstan in 1992, at the 47th Session of the United Nations General Assembly. The driving force behind this initiative was the aspiration to set up an efficient structure for ensuring peace and security in Asia. CICA is a multi-national forum based on the recognition that there is a close link between peace, security and stability in Asia and in the rest of the world.

The Conference on Interaction and Confidence Building Measures in Asia, CICA, comprises 28 member states from Asia. The Azerbaijani Chairmanship of CICA is grounded in the theme of "Stronger CICA – Connectivity, Digitalization, and Sustainable Growth in Asia". Azerbaijan's Chairmanship will focus on increasing CICA's international visibility and expanding its network of partnerships with other international organizations. For the sake of peace and prosperity in Asia, I wish the APA continued success.

However, time constraint could not cause any hindrances on our will for joining together once again in the historical city of Baghdad.

In response to your commendable effort and firm conviction, I would like to highly appreciate your presence at this event in Baghdad at such a delicate situation we are facing and express my special thanks to the Iraqi Council of Representative for the excellent organization of the meeting and their generous hospitality extended to us.

Based on this sense of responsibility and positive attitudes that every one of you have in respect of our APA community, we are now holding this Committee meeting to wrap up successfully the last leg of sessions of the four Standing Committee Meetings.

#### **Dear Colleagues**

As you may have duly noticed, APA has undertaken some policy changes during the past few months to speed up its pace for further advancement of the its regular programs. At the initiative of the APA Secretariat and close cooperation and coordination of the APA Presidency, we succeeded to benefit from the potential capacity of the Standing Committee Meetings and organize couples of side events. This policy which was initiated during our SC Committee Meeting in Moscow received further support of the APA Presidency, currently leading to the regular convening of Bureau Meetings as the key element and driving force to speed up adoption of decisions. The key element for added

value of this policy had led to further success of our Standing Committee Meetings leading to give further momentum to the APA programs.

#### Dear Colleagues,

As you may recall, at its last meeting in Baghdad on 10-11 Nov 2023, the SC on Political Affairs decided to center its focus on consideration of "<u>Asian Parliaments' Unwavering Support for the Palestinian People"</u>, as response to turbulent situation in the Gaza Strip as the only resolution to be considered by the meeting and leave consideration of all other draft resolutions before the Committee to a later date.

Due to the critical situation lingering over the Gaza Strip following the heinous crimes committed by the Apartheid Regime of Israel, this decision received welcome support of the participants and after thorough deliberation the resolution was referred to a drafting committee for final adoption as an indication of firm solidarity and unwavering support to the Palestinian people.

The Standing Committee Meeting on Political Affairs in Baghdad also adopted a final document that affirmed the rights of Palestinian people to struggle and legitimate resistance by all available means for the establishment of an independent Palestinian state with Al-Quds as its capital.

It also called for ending the occupation and aggression of the Zionist entity to all Palestinian, Syrian and Lebanese territories as it represents the path of peace, stability and prosperity

The adopted resolution was approved by the 1st Executive Council Meeting in Nov. 2023, in Antalya, Türkiye. The 1<sup>st</sup> Executive Council also approved establishment of the "Committee on Palestine" which was endorsed by 14<sup>th</sup> APA Plenary in Baku, Republic of Azerbaijan

The 1<sup>st</sup> meeting of the Committee on Palestine was held on 9-11 January 2024 in Tehran. It is an opportune moment and welcome coincidence that we are holding the 2<sup>nd</sup> Meeting of the Committee on Palestine at the same time in the year 2025; thanks to our Iraqi brothers for their invaluable initiative deciding to hold the 2<sup>nd</sup> Palestine Committee Meeting alongside of the SC Committee on Political Affairs.

Today, the Standing Committee on political Affairs has before it the following 8 draft resolutions for consideration as itemized below under relevant titles on:

- 1. Good Governance
- 2. The Rule of Law and Judicial Empowerment
- 3. Good Parliamentary Practices

- 5. Asian Parliaments and Governments Together for Prosperity in Asia
- 6. Harmonious Development through Democracy
- 7. Asian Parliaments' Unwavering Support for the Palestinian People

8. Enhancing Cooperation among the Members of the Asian Draft Parliamentary Assembly to Protect and Promote Multilateralism

#### I. Introduction (Jika Diperlukan)

Assalamualaikum Wr., Wb. May the peace, mercy and blessings of Allah be upon us all,

Allow me begin by congratulating the Council of Representatives of the Republic of Iraq on their warm hospitality, as well as the great organizing and facilitation of this meeting. My name is Mardani Ali Sera, Chair of the Committee of Inter-Parliamentary Cooperation of the Indonesian House.

Honorable Chair, Honorable Delegates, Ladies and gentlemen,

Indonesia welcomes the draft resolutions prepared by the APA Secretariat, especially the new draft resolution regarding the need to protect and promote multilateralism. As we currently understand, multilateralism seems to be increasingly weakening.

Especially given the huge gap between people's aspirations and the response of global institutions, that sometimes did not result in a global decision. This situation then becomes the reason why people in various parts of the world are pressing for stronger democratic accountability from international organizations.

The situation in Gaza for instance. Even though violations of international law have been apparent there, global institutions do not immediately respond. Sometimes they are even held hostage by the unilateral actions of certain countries.

In such setting, we cannot rely only on policy proposals from certain countries. Nor any unilateral act that undermine the will of the majority of international society.

We, as parliamentarians, must remain confident that global governance is still the most viable and significant concept for addressing today's complex challenges.

Parliament must also continually play a role in global governance by reaffirming legislative participation in international diplomatic forums. So that we may participate more actively in global governance talks on numerous present-day issues.



Hopefully, through this meeting, we can work together to produce political documents that have an impact and are able to increase the role of our organization on various important global issues.

#### II. Views on Draft Resolutions

#### 1. Draft Resolution on Good Governance

Indonesia proposes to add new paragraphs on the preamble section of this draft resolution, as follows:

Having aware that parliament serves as the bedrock institution of good governance whereby through its functions in legislation, robust oversight mechanism, budgetary provision, and public grievance channel, the national policies can reflect best the interest of the public;

Deeply concerned about emergencies, including those arising from pandemics and natural disasters, and their impact on, inter alia, good governance, the rule of law at all levels and the achievement of the SDGs, in particular Goal 16 on promoting peaceful and inclusive societies for sustainable development, providing access to justice for all and building effective, accountable and inclusive institutions at all levels, and its targets;


**Emphasizing** the need to foster inter-parliamentary cooperation including through collaboration with other relevant inter-parliamentary institutions such as the Inter-Parliamentary Union (IPU), the Global Organization of Parliamentarians against Corruption (GOPAC), among others as a way to strengthen measures on good governance;



The paragraphs that we proposed were aimed to underline the critical role of a legislative institution in shaping a good governance regime at the national level. Further, we also would like to recommends parliament of Asian Countries to consider measures to strengthen the governance during times of emergency, as a way to address corruption and potential of abuse during crisis/emergency ensure that there is a system of checks and balances, and encourage the embodiment of good governance.

Therefore, we also propose to add new paragraphs on the Operative section of this draft resolution, as follows:

Urge Member Parliaments to further the full and effective use of the UN Convention Our against Corruption to develop, put in place, and where appropriate, improve and



strengthen anti-corruption policies and strategies, in accordance with domestic law as part of the steps taken to enhance good governance and the rule of law:

Recommend Member Parliaments to adopt, should have not done so, or strengthen the emergency protocol with robust governance framework legislation as a way to ensure its preparedness and address corruption during times of emergencies, crisis response and recovery;

We also would like to propose an additional paragraph on the last part of the operative section as follow:

**Task** APA Secretariat to pursue stronger partnership, cooperation and collaboration with relevant inter-parliamentary institutions working to promote good governance and rule of law, and combat corruption.

The proposed paragraph is a suggestion for APA to move forward a potential partnership with other relevant Inter-Parliamentary Institutions which has concern and operates in the field of good governance.

#### 2. Draft Resolution on the Rule of Law and Judicial Empowerment



Regarding to this draft resolution, it is important to understand that the rule of law should also be protected through ensuring the independency of the judiciary and its ethics supremacy. Therefor, we would like to propose in the operative section as follow:

**Promote** parliamentary measures to protect the independency of the judiciary in making impartial decisions free from any interventions and provide an adequate proper oversight control as a way to ensure the ethics supremacy among judiciary authorities;



Furthermore, we would also like to propose a new paragraph which highlight

a new reality which was started by Israel in disregarding, ignoring, and violating the international law, international human rights law, and humanitarian laws, that should be condemned as it is ignoring the way the international rule of law works.

**Condemn** in its strongest term the consistent and continued blatant violations of international human rights and humanitarian laws, a manifestation of total disregard and ignorance of the international rule of law, by Israeli authorities in Gaza and the Occupied Palestinian Territory;

#### 3. Draft Resolution on Good Parliamentary Practices



We propose to add document references in the preamble section of this draft resolution, on the urgency of having good parliamentary practice. The propose paragraph are as follows:

**Referring** to the Open Government Partnership (OGP) Memorandum on Parliamentary Engagement whereby parliamentary engagement has been an integral part of the open government philosophy and a key element to achieve ambitious open government reforms;

**Taking into account** the Declaration on Parliamentary Openness launched at the World e-Parliament Conference 2012 in Rome Italy which provide a general guide and scope of openness and good parliamentary practices to the legislative institutions;

We also propose an additional paragraph on the operative section as follow:

**Encourage** Member Parliaments to strengthen their involvement and engagement to OGP through the possible development of a stand-alone of Open Parliament Action Plan, aiming for a better and good parliamentary practice;

The paragraph proposes to develop an Open Parliament Action Plan as part of engagement with the Open Government Partnership (OGP), an international organization dedicated to promote openness and transparency. Such measure is aiming to better the existing parliamentary practices.

#### 4. Draft Resolution on Harmonious Development through Democracy

Indonesia welcomes the draft resolutions on Harmonious Development through Democracy considering the fact that collected strategies pursued by APA in the Resolutions of Standing Committee on Political Affairs are consistent with our foreign policy objectives, and therefore, we have always been committed with any programs and actions to promote democratic values.

Having said that, we would like to propose additional paragraph in the operative section of this draft resolution, that aims to underline that democracy needs parliament to functions given its roles of check and balances. Thus, the parliament itself needs to be strengthened.

The propose paragraph are as follows:

Stress the need to strengthen parliament as an institution of check and balances, holding the government to account for every political, socio-economic development policies it creates and implements;

Regarding the resolution "Asian Parliaments' Unwavering Support for the Palestinian People", in principle the contents of the resolution are in line with the various basic positions of the OIC regarding the situation in Gaza, but a number of sentences can be strengthened with updated elements agreed upon by the OIC and international forums.

We therefore propose additional paragraphs on the Preamble section of this draft resolution as follows:

**Welcoming** the advisory opinion of the International Court of Justice (ICJ) of July 2024 on the legal consequences arising from Israel's policies and practices in the Occupied Palestinian Territory (OPT), including East Jerusalem, and from the illegality of Israel's continued presence in the OPT;

Also welcoming the UN General Assembly (UNGA) resolution A/ES-10/L.31/Rev.1 in follow-up to the advisory opinion of the ICJ adopted at the tenth emergency special session, 13 September 2024;

Further welcoming the International Criminal Court (ICC) issuance of warrants of arrest for crimes against humanity and war crimes on 21 November 2024;

Also, an additional paragraph that combines with the initial paragraph line 15 in the preamble section. The new combined paragraph will be as follow:

**Alarmed** by the persistent and continuous attack to health facility and personnel as well as humanitarian officers which have left the Gaza Strip's health system severely under-resourced and **regretting** the surge in violence in Gaza since 7 October, 2023 and loss of all civilian lives;

Accordingly, we would also like to propose resentencing for Operational Paragraph one, to be as follow:

**Urge** all Members of the APA to ensure their governments recognize the State of Palestine and support the full membership of Palestine in the United Nations

This paragraph is to emphasize support for full membership of Palestine in the UN as well as expanding recognition of Palestine consistently agreed upon within the OIC framework, especially in the Resolution of the 5th OIC Summit and the Joint Extraordinary Summit of the OIC-Arab League.

We also propose to resentence Operational Paragraph two, to be as follow:

Also urge the international community to put pressure to Zionist Entity to stop its military aggression against the people of Gaza Strip through an immediate and permanent ceasefire.



This paragraph we propose is aim to affirm the common position in various OIC meetings, including the OIC-Arab League Extraordinary Joint Summit, particularly to expedite a permanent ceasefire.

On Operational Paragraph 6, Indonesia would like to add the UN General Assembly (MU) Resolution ES-10/24, which regulates the end of the Israelii occupation which has been agreed in the context of the OIC, as follow:

Welcome the adoption of the UN General Assembly Resolution ES-10/24 on September 18, 2024, which endorses the International Court of Justice's legal advisory opinion dated July 19, 2024 aimed at ending the Israeli occupation and call for its full implementation


On Operational Paragraph twenty-one, regarding support for UNRWA, which has been consistently agreed upon in the framework of the OIC. The OIC also condemned the Knesset's legislation (Israeli Parliament) which prohibited UNRWA's operations in the OPT (Occupied Palestinian Territory) area:

Reject and condemn the Knesset's laws banning UNRWA's operations in the Gaza Strip, West Bank and East Jerusalem, and urge the international community to safeguard UNRWA's indispensable role in delivering lifesaving services to Palestinians without any obstruction.

On Operational Paragraph thirty, to add after the word people:

Encourage the member parliaments of the Asian Parliamentary Assembly take political initiatives and adopt positions that support the legitimacy of the Palestinian cause and the legitimate struggle of the Palestinian people including abstaining from treaty relations with, entering into economic relations or trade dealings with, and in the establishment and maintenance of diplomatic missions in Israel as mandated by the UNGA resolution A/ES-10/L.31/Rev.1 adopted in September 2024.


#### Assalam-o-Alaikum!

### Speech of the Head of the Russian Delegation at the APA Standing Committee Meeting on Political Affairs

(Baghdad, Iraq, 11-12 January 2025)

Your Excellency Mr. Chairman,

Mr. Secretary-General,

Excellencies, esteemed colleagues,

On behalf of the Russian delegation, I would like to express our gratitude to the Iraqi Council of Representatives for the warm welcome and hospitality we enjoy here as well as for the opportunity to speak today.

We are thankful to the Secretariat for facilitating the Assembly's activities and preparing the important and necessary documents that we have been working with.

I want to emphasise that the Asian Parliamentary Assembly, as a unique platform for parliamentary cooperation uniting representatives from legislative bodies across nearly all Asian states, is not only a vital dialogue mechanism for exchanging views and experiences, but also an effective tool for achieving a common vision and harmonised positions in line with global and regional agendas.

Having emerged as complementary to the efforts of executive authorities, parliamentary diplomacy has now become an inherent part of international relations, a distinct and responsible area of work for legislators across the globe. Importantly, parliamentary diplomacy has not devolved into a rigid mechanism; it retains a dynamic and live character. For this reason, parliamentarians are often among the first to respond understandingly to new trends in international affairs that today are undergoing a challenging period of transformation, marked by the establishment of a new world order. Our task is to not merely witness this process but actively participate in it.

First and foremost, it is crucial for us as legislators to focus on upholding the principle of the supremacy of international law. Successful cooperation can only occur on the basis of commonly accepted legal rules. It is worth noting that most of these principles, enshrined in the UN Charter, were born out of the serious ordeal humanity faced in the world wars and are a result of balanced decisions and compromise.

It is no secret that today's attack on national sovereignty and economic competitiveness often begins with attempts to undermine spiritual and cultural foundations. My country is one of the largest multinational states in the world. The Russian nation and society have historically been built on the friendship and agreement of a wide range of ethnic groups inhabiting the territory of the country, fostering intercultural and interethnic interaction. This is our pride and strength. Today, as global discussions focus on countering polarization across various divides, including cultural and ethnic lines, Russian society exemplifies the unity of its peoples, solidarity around traditional moral values: strong families, productive work, historical memory, compassion, intergenerational continuity, and many others.

We strive to uphold the principles of solidarity in our international activities as well. Russia has always advocated for justice and mutual coexistence of cultures, ethnicities, and religions. Together, these elements lay the foundation for a global humanitarian dialogue that we engage in with all stakeholders.

We are convinced that a comprehensive approach is necessary to overcome the Middle Eastern crisis. The key to restoring stability in the region lies in normalising the situation in the context of the Palestinian-Israeli conflict. Unfortunately, the situation continues to deteriorate. As a result of the Israeli army barbaric actions in the Gaza Strip, innocent civilians continue to suffer. The scope of the humanitarian catastrophe is growing.

We extend our heartfelt condolences to the families and loved ones of those whose lives have been claimed by the armed confrontation and stand in solidarity with all the victims. We hope the humanitarian situation in the crisis zone will be improved. Any violence against civilians, as well as strikes on civilian infrastructure, including medical facilities and areas populated by the elderly, women, and children, is absolutely unacceptable.

Russia's position on the Palestinian-Israeli conflict and the quest for durable peace in the region is well-known and consistent. First of all, we must achieve an immediate, permanent, and comprehensive ceasefire, along with a humanitarian truce to provide assistance to all those in need. We endorse the key mandate of UNRWA as a unique agency dedicated to assisting the Palestinian people and underscore the importance of de-escalating hostilities and rejecting violence.

We stand for a full revival of the political and diplomatic process aimed at reaching a long-term and just resolution to the inveterate Middle Eastern conflict, a resolution underpinned by internationally recognised laws, including relevant UN Security Council resolutions. The outcome must be the establishment of an independent Palestinian state within the 1967 borders, with East Jerusalem as its capital, coexisting peacefully and securely alongside Israel. It is the only approach to deliver a sustainable solution and break the cycle of violence.

We welcome the resolution adopted in May 2024 by an overwhelming majority at the UN General Assembly endorsing the admission of Palestine as a full member of the United Nations.

Therefore, the Russian delegation, while largely supporting the spirit of the Draft Resolution on Asian Parliaments' Unwavering Support for the Palestinian People, would like to underscore the need to use the terminology and wording enshrined in the resolutions of the UN Security Council and General Assembly, which align with the high level of the Asian Parliamentary Assembly's activities.

We believe it is crucial to further enhance inter-parliamentary cooperation within the APA, aimed at ending the suffering of the people in Gaza and promoting the use of peaceful political and diplomatic means to achieve a comprehensive resolution to the Palestinian-Israeli conflict and, more broadly, the Middle Eastern conflict, whose escalation has destabilised the entire region.

We have drafted and will send the text of Dissenting Opinion of the Russian Delegation to the Secretariat and we request to attach it to the Resolution on Asian Parliaments' Unwavering Support for the Palestinian People.

On 27 November, a Lebanese ceasefire agreement entered into force. This raises hopes that the peak of the armed escalation in the region may have passed with the possibility to avoid a large-scale conflict this time. One can only hope that the agreements reached will be upheld to manifest

an important step towards a lasting and well-balanced stabilization of the volatile situation in the Middle East as a whole. However, regrettably, we cannot be fully confident in this outcome. Both sides have already accused each other of numerous violations of the ceasefire.

We are deeply concerned about the dramatic events unfolding in Syria. We express our solidarity with the Syrian people who have historically been friends with Russia. The Russian Federation keeps in touch with all factions of the Syrian opposition.

We reaffirm our strong standing in support of the sovereignty, unity, and territorial integrity of the Syrian Arab Republic. We urge all the parties involved to renounce violence, to resolve all governance issues through political means, and to respect the views of all ethnic and religious groups within the Syrian society.

We deem it extremely important that all the parties should contribute to expediting stabilization of the situation, ensuring the rule of law and maintaining order, preserving peace and harmony, and preventing violence and bloodshed.

Dear friends, cooperation among parliamentarians serves as the foundation for the prosperity of the modern world. Russia is firmly committed to further developing constructive, equal, and mutually beneficial partnerships with all interested parties.

### **Draft Resolution on Good Governance**

We, the Members of the Asian Parliamentary Assembly,

**Realizing** that good governance is inextricably linked to sustainable development, which leads to stability and prosperity;

**Taking** in to account all characteristic of Good Governance and their effects on achievement of SDGs and prosperity of human being;

**Recognizing** the importance of good governance in the achievement of SDGs as one of means to build peaceful, just and inclusive societies;

*Having aware* that parliament serves as the bedrock institution of good governance whereby through its functions in legislation, robust oversight mechanism, budgetary provision, and public grievance channel, the national policies can reflect best the interest of the public;

**Deeply concerned** about emergencies, including those arising from pandemics and natural disasters, and their impact on, inter alia, good governance, the rule of law at all levels and the achievement of the SDGs, in particular Goal 16 on promoting peaceful and inclusive societies for sustainable development, providing access to justice for all and building effective, accountable and inclusive institutions at all levels, and its targets;

**Emphasizing** the need to foster inter-parliamentary cooperation including through collaboration with other relevant inter-parliamentary institutions such as the Inter-Parliamentary Union (IPU), the Global Organization of Parliamentarians against Corruption (GOPAC), among others as a way to strengthen measures on good governance;

- **Reiterate** that good governance is a key to achieving inclusive economic, social and institutional development;
- **2. Recognize** that transparency in all its forms and manifestations, free, responsible media, popular participation in government, and a vibrant civil society are the essential of good governance;
- **3. Stress** upon the Member Parliaments to identify gaps in governance which may lead to poverty, injustice and inequality;
- **4. Urge** Member Parliaments to further the full and effective use of the UN Convention against Corruption to develop, put in place, and where appropriate, improve and

- strengthen anti-corruption policies and strategies, in accordance with domestic law as part of the steps taken to enhance good governance and the rule of law;
- **5. Recommend** Member Parliaments to adopt, should have not done so, or strengthen the emergency protocol with robust governance framework legislation as a way to ensure its preparedness and address corruption during times of emergencies, crisis response and recovery;
- **6. Call upon** Member Parliaments to ensure as appropriate enhanced participation of women, youth and persons belonging to national or ethnic, religious and linguistic minorities in the national political process in accordance with the domestic laws of member countries;
- **7. Task** APA Secretariat to pursue stronger partnership, cooperation and collaboration with relevant inter-parliamentary institutions working to promote good governance and rule of law, and combat corruption.
- **8. According** to the APA Charter in Article 16 and Article 15 of its By-Law, we hereby suggesting to establish a sub-committee from APA Member States to evaluating the performance of APA Parliaments and governments in terms of their commitment to the resolutions of the Political Committee of the Asian Parliamentary Assembly.



### Draft Resolution on the Rule of Law and Judicial Empowerment

We, the Members of the Asian Parliamentary Assembly,

**Reaffirming** the universal realization of the right of peoples under colonial, foreign and alien dominations to self-determination is a fundamental condition for the effective guarantee and observance of human rights and for the preservation and promotion of such rights;

**Recalling** the principles of the Charter of the United Nations, including those of sovereign equality and independence of all States, which are indispensable foundations for a more peaceful, prosperous and a conflict free world;

**Recognizing** that the rule of law at national and international levels is equally essential for all states and respect for and promotion of the rule of law and justice are the guiding principles for every state;

**Further** recognizing that all persons, institutions and entities, public and private, have a right to be accorded equal protection of the law and to be treated in accordance with the law, without any discrimination;

**Reaffirming** the duty of all Member States to settle their international disputes through peaceful means, including, negotiation, mediation, conciliation, arbitration and judicial settlement;

**Further reaffirming** that the rule of law is an essential assurance for independence of judiciary and improves the protection of human rights;

*Convincing* that the rule of law and sustainable development are inextricably linked and mutually reinforcing and contribute to the realization of human rights and fundamental freedoms;

**Supporting** the principles of sovereign equality of states, non-intervention in the internal or external affairs of states and condemning as a violation of this principle any interference by any states in the internal affairs of other states with the aim forging change of legitimate governments or affecting their external affairs,

*Stressing* that the key role in maintaining of the rule of law concerns states and those international efforts to strengthen the rule of law should complement national efforts, but not substitute them;

- 1. Stress the importance of capacity development through rule of law;
- **2. Emphasize** the importance of institutional strengthening by maintaining the rule of law:

- **3. Promote** parliamentary measures to protect the independency of the judiciary in making impartial decisions free from any interventions and provide an adequate proper oversight control as a way to ensure the ethics supremacy among judiciary authorities;
- **4. Stress** also the necessity for strengthening the international judicial cooperation among judicial authorities of all Member States.
- **5. Urge** Member Parliaments to ensure compliance with internationally agreed human rights and humanitarian laws, in a manner that does not conflict with the social values and religious constants of Member States.
- **6. Condemn in its strongest term** the consistent and continued blatant violations of international human rights and humanitarian laws, a manifestation of total disregard and ignorance of the international rule of law, by Zionist Entity authorities in Gaza and the Occupied Palestinian Territory;
- **7. Encourage** the promotion of a system of justice which incorporates the full range of judicial measures to ensure accountability, justice, provide remedies to victims, reconciliation, and establish independent oversight;
- **8. Reiterate** our strong and unequivocal condemnation of terrorism, extremism in all its forms and manifestations, committed by whomever, wherever and for whatever purposes, as it constitutes one of the most serious threats to the rule of Law;
- **9. Emphasize** the importance of our continued efforts for promotion of the rule of law in all its aspects, and to take steps to strengthen the rule of law for realization of peace and security, human rights and development.

### **Draft Resolution on Good Parliamentary Practices**

We, the Members of the Asian Parliamentary Assembly,

*Noting* the ever increasing and assertive role of parliaments in public affairs and in the promotion of democratization for ensuring good governance;

**Referring** to the Open Government Partnership (OGP) <u>Memorandum on Parliamentary</u> <u>Engagement</u> whereby parliamentary engagement has been an integral part of the open government philosophy and a key element to achieve ambitious open government reforms;

**Taking into account** the <u>Declaration on Parliamentary Openness</u> launched at the World e-Parliament Conference 2012 in Rome Italy which provide a general guide and scope of openness and good parliamentary practices to the legislative institutions;

**Taking** into account the fact that 181 states have adopted parliamentary systems for managing their national affairs;

*Taking* into account the cultural diversity, role of persons belongs to minorities, diversity of religions, faith and ethnics in all Asian societies;

**Noting** the cardinal role that parliaments play in a democratic polity and in addressing issues of public importance;

**Recognizing** that parliaments must be truly representative, transparent, accessible, accountable and effective in its functions;

- 1. Urge APA Member Parliaments to adopt transparent modes of the communications of the public of communication with the public, through ensuring access to their Parliamentary system and to develop their own websites and broadcasting channels;
- 2. Further **urge** APA Member Parliaments to devise effective outreach mechanisms for engagement with public, including, civil society, with a view to ensuring their meaningful contribution in the legislative processes;
- **3. Call upon** APA Member Parliaments to adopt measures for ensuring public confidence in the integrity of parliamentarians, through enforceable codes of conduct and transparency in managing the affairs of political parties and their funding;
- **4. Encourage APA** Member Parliaments to streamline their legislative process by encouraging the transparency and public participation through public hearing in respective constituencies;

- **5. Call upon** APA Member Parliaments to ensure their effective participation at regional and international forums with a view to promoting transnational collaboration amongst Member Parliaments and to devise a strategy towards this end by the APA;
- **6. Encourage** Member Parliaments to strengthen their involvement and engagement to OGP through the possible development of a stand alone of Open Parliament Action Plan, aiming for a better and good parliamentary practices;
- **7. Also call upon** APA Member Parliaments to ensure their oversight of the executive, particularly, in the formulation of international policy, and to make recommendations to their respective governments towards a peaceful settlement of international disputes;
- **8. Urge** APA Member Parliaments to adopt positive measures for ensuring a meaningful participation of women, minorities and vulnerable groups in their working;
- 8. **Call upon** APA Member Parliaments to promote inter-parliamentary cooperation through formation of friendship groups and working groups on issues of common interest:
- 9. **Further Call upon** APA Member Parliaments to encourage developing democracies through sharing their experiences and best parliamentary practices and provide technical and other required support with a view to facilitate their process of democratization.



### Draft Resolution on Building Prosperity in Asia through Friendship and Cooperation

We, the Members of the Asian Parliamentary Assembly,

**Recalling** relevant APA resolutions on Advancing the Principles of Friendship and Cooperation in Asia (APA/Res/2015/01—11 December 2015); Resolution on Measures and Methods of Materialization of Principles of Friendship and Cooperation in Asia (APA/Res/2014/01—3 December 2014); Resolution on Consolidation of Friendship and Cooperation in Asia (APA/Res/2013/01-- 9 December 2013); Resolution on Reinforcing the Declaration on Principles of Friendship and Cooperation in Asia (APA/Res/2010/09—30 November 2010); Resolution on Pursuing Implementation of the Declaration on the Principles of Friendship and Cooperation in Asia (APA/Res/2008/09, 29 November 2008) and Resolution on the Friendship Pact in Asia; (APA/Res/2007/06, dated 19 November 2007); Text of the Declaration on Principles of Friendship and Cooperation in Asia (APA/Res/2007/06/Annex, 19 November 2007);

**Relying** on deep-rooted ties of history, geography, culture, economy, politics, and civilization which bind Asian nations together;

**Recognizing** the amity and the friendly relations among the Asian Nations, Parliaments, and States as an indispensable asset which need to be further strengthened by all kinds of intergovernmental; inter-parliamentary as well as inter-national interaction and cooperation;

Deploring the current widespread war and violence in West Asia which undermine peace and security and entail massive killing and indiscriminate targeting of innocent people;

Offering in Good Faith all our capacities and capabilities in parliamentary diplomacy for mediation, reconciliation, and supporting dialogue with a view to promoting friendship and cooperation and contribute to peaceful resolution of conflicts in Asia;

*Emphasizing* the fundamental role of the principles of sovereign equality, political independence, the territorial integrity of States, the non-use of force or of the threat of use of force in international relations and non-interference in internal affairs of States in the promotion of friendship and cooperation in Asia and calling upon all Member Parliaments and their respective Governments to ensure equal and non-discriminatory access of their citizens to civil political, economic, social and cultural rights;

**Reiterating** the importance of the APA Declaration on the Principles of Friendly Relations in Asia as a proper framework for promoting peace and prosperity in Asia;

**Encouraging** all member states to enhance public relations among nations of different countries in order to better understand of each other and to strengthen the friendly relations among nations; **Also Encouraging** further expansion of friendly relations including cultural, diplomatic, scientific, and commercial relations among all Asian States and further interaction among Asian Parliaments and Nations in pursuance of the purposes of the Declaration;

*We therefore,* 

- 1. Call upon all Member States to focus on exchanging cultural experiences and deepening social communication through holding forums and events under the umbrella of the Asian Parliamentary Assembly, for the positive objectives that benefit the Member States;
- **2. Encourage** collective and concerted efforts by all APA Members to provide humanitarian assistance of all kinds to the vulnerable people in war- torn countries;
- **3. Call Upon** all Asian States to direct their diplomatic efforts at reducing political tensions and utilize all ways and means within their power to avoid and de-escalate controversies which have potential to undermine principles of friendship and cooperation in Asia;
- **4. Welcome** the initiative of the Inter-Parliamentary Union supported by the United Nations General Assembly Resolution 72/278 to organize a world conference on interfaith and inter-ethnic dialogue with the participation of Heads of State, parliaments and world religions.
- **5. Call** Asian Parliaments to disseminate information about the APA Declaration on the Principles of Friendship and Cooperation in Asia by all available means including parliamentary and state publications, parliamentary friendship groups, public programs, etc.
- **6. Promote** that every Member Parliament would motivate public and private media networks, websites and the like at local and national levels to engage in promoting and spreading the word about the content, importance and positive results of the adoption and implementation of the APA Declaration on the Principles of Friendship and Cooperation in Asia;
- **7. Encourage** Asian academic institutions, think-tanks and research centers, universities and educational institutions, as well as professional associations throughout Asia to take part in promoting and adhering to the tenets and guidelines enshrined in the APA Declaration on the Principles of Friendship and Cooperation in Asia,

### Draft Resolution on Asian Parliaments and Governments Together for Prosperity in Asia

We, the Members of the Asian Parliamentary Assembly,

**Recalling** APA resolutions on Mobilizing Interactions Between APA and Asian Governments (APA/Res/2015/02—11 December 2015); Engaging APA with Asian Governments and Inter-Governmental Organizations (APA/Res/2014/02); Asian Parliaments and Governments: Together for Solidarity and Prosperity in Asia (APA/Res/2013/02 –9 December 2013); Measures for Enhancing Cooperation Between APA and Asian Governments (APA/Res/2010/11, 30 November 2010) and resolution on Enhancing Cooperation Between Asian Parliamentary Assembly Member Parliaments and Their Governments for Implementation of APA Decisions (APA/Res/2008/10, 29 November 2008);

*Emphasizing* the need to foster closer coordination and cooperation between APA and Governments of APA Member Parliaments;

*Taking* note of the necessity of smooth cooperation and coordination Parliaments and Governments in order to pass relevant enactments;

*Encouraging* Member Parliaments to consider endorsing and adopting common legislations on issues of mutual interest to both APA and Asian Governments;

- 1. Call all Member Parliaments to inform relevant high-ranking officials of their respective governments of the great potentials, activities, and achievements of the APA as the largest inter-parliamentary organization in Asia and report thereon to the Secretariat for circulation:
- 2. Decide to form APA parliamentary groups comprising nominated delegates from volunteer Member Parliaments under the supervision of the APA Vice-President for Political Affairs and in full coordination with the APA Secretariat, to hold contacts and meetings with relevant inter-parliamentary and inter-governmental organizations, with a view to converging points of view and considering possible joint initiatives pertaining to regional and global issues, including the creation of an Asian Parliament;
- **3. Request** APA Member Parliaments to identify and describe heir priority desirable topics for receiving training, as well their capabilities to offer training and best practices, and share them with other Parliaments through the APA Secretariat, in order to organize training programs on exchanging best practices and learning from each other;
- **4. Encourage** as appropriate APA Member States to actively participate in and promote the implementation of relevant international treaties and agreements aimed at

ensuring the equitable and sustainable sharing of transboundary water resources, particularly with neighboring countries.



### **Draft Resolution on Harmonious Development through Democracy**

We, the Members of the Asian Parliamentary Assembly,

**Recalling** the principles and purposes of the United Nations Charter, which reaffirms the dignity and worth of human beings, in the equal rights of nations large and small and the principle of the sovereign equality of the UN Members;

**Recalling** also the United Nations Member commitment stipulated in the UN Charter to employ international machinery for the promotion of the economic and social advancement of all people;

**Reiterating** that democracy, dignity of human beings, rule of law and justice are universal, interconnected, mutually reinforcing and crucial for development;

**Recognizing** that the eradicating poverty in all its forms and dimensions, including extreme poverty, is the greatest global challenge and an indispensable requirement for sustainable development and in this regard, stressing on the importance of an enabling environment based on principals of democracy for the promotion of higher living standards, decent employment, and conditions for economic and social progress and development;

*Mindful* of the need for leading role of Parliaments towards the full realization of SDGs;

- 1. Acknowledge the core role of Parliaments in the socio-economic development by involving the will of the people through transparent, accessible, accountable and effective institutions at all levels;
- **2. Stress** the need to strengthen parliament as an institution of check and balances, holding the government to account for every political, socio-economic development policies it creates and implements;
- **3. Affirm** democracy, transparency and accountability among the important means to sustainably end poverty, promote shared prosperity and the basic social and economic needs;
- **4. Commit** to remove and eradicate all obstacles in the administration of socioeconomic polices and all forms of discriminations, including, but not limited to race, color, creed, cast, sex, language, religion, nationality, and ethnicity;
- **Recognize** the need for active engagement with civil society organization and youth at all tiers of governance to ensure equitable development;

- **6.** Recognize also the effectiveness of women's participation as one of the most important contributors to sustainable development, given their assumption of leadership position to promote democracy and gender equality,
- 7. Urge that APA Members Parliaments shall continue to encourage sustainable human development through social security programs for vulnerable groups of the society;
- **8. Acknowledge** that regional disparities in economic development are amongst the leading causes of marginalization of efficacy and efficiency of democratic setups, requiring affirmative actions to bring equitable and judicious development across the region;
- **9. Emphasize** to improve regional and inter-regional connectivity to promote socioeconomic development of the people of Asia;
- **10. Urge** APA Members to generate an informed debate and share experiences at APA platform on the democratic process leading to development.



### Draft Resolution on Asian Parliaments' Unwavering Support for the Palestinian People

We, the Members of the Asian Parliamentary Assembly,

**Recalling** APA Resolutions on Supporting Palestinian State and Protecting Rights of Palestinian People, (APA/Res/2013/03, 9 December 2013); Violations of International Humanitarian Law in the Palestine and the War Crimes Committed By the Zionist entity in Gaza (APA/Res/2009/01, 8 December 2009); and Humanitarian Crisis in Palestine Particularly in the Gaza Strip (APA/Res/2008/08, 29 November 2008); the catastrophic humanitarian impact of the aggressive war on the Gaza Strip in July 2014. and Zionist entity indiscriminate bombardment on the Gaza Strip since 7 October 2023 which deliberately targeting the civilians including women and minors;

Also recalling the resolutions of the United Nations Security Council, including resolutions 242 (1967), 252 (1968), 267 (1969), 298 (1971), 446 (1979), 465, 474, 478 (1980), 468 (1980) and 1322 (2000), 2334 (2016), and resolutions of the United Nations General Assembly and other relevant international documents.<sup>1</sup>

*Welcoming* the advisory opinion of the International Court of Justice (ICJ) of July 2024 on the legal consequences arising from Zionist Entity policies and practices in the Occupied Palestinian Territory (OPT), including East Jerusalem, and from the illegality of Zionist Entity continued presence in the OPT;

*Also welcoming* the UN General Assembly (UNGA) resolution <u>A/ES-10/L.31/Rev.1</u> in follow-up to the advisory opinion of the ICJ adopted at the tenth emergency special session, 13 September 2024;

*Further welcoming* the International Criminal Court (ICC) issuance of warrants of arrest for two high Zionist Entity officials , for crimes against humanity and war crimes on 21 November 2024;

**Inspired** by the Principles and objectives enshrined in the APA Charter and the relevant APA resolutions;

**Committed** to contribute to the promotion of peace and security at regional and global levels on the basis of justice and the rule of law;

Affirming the responsibility of the international community to support implementation of resolutions and recommendations of the United Nations Security Council; the UN General Assembly; the Human Rights Council; International Court of Justice the APA pertinent to the situation in Palestine, particularly in Al-Quds and the advisory opinion of the ICJ and warrants of arrests from the ICC:

*Supporting* the struggle of Palestinian people against Zionist Entity occupation by its all means to liberate its land and establish an independent Palestinian State with Al-Quds city as its Capital and the right of return to the Palestinian refugees as mentioned in Security Council Resolution 104,

**Reemphasizing** the denunciation of the transfer of the American Embassy from Tel-Aviv to the occupied city of Jerusalem in disregard of the principles and rules of international legitimacy and UNSC Resolutions:

*Expressing* serious concerns on Zionist Entity's lack of commitment to abide by resolutions and recommendations of the UN Security Council, the General Assembly, the Human Rights Council, International Court of Justice the Inter-Parliamentary Union, and the APA regarding the human rights situation in the occupied Palestinian territories, particularly in Al-Quds; and the Gaza Strip;

**Reaffirming** the applicability of the fourth Geneva Convention relative to the protection of Civilian Persons in Time of War, of 12 August 1949, to the occupied Palestinian territories, including AlQuds and the Gaza Strip;

**Recognizing** that Zionist Entity's genocide and severe violations of international humanitarian law and of the human rights of Palestinian people undermine international efforts towards achieving a just and lasting peace in the region and beyond;

**Noting** with grave concern over the continuous and blatant violations of Zionist Entity to various UN resolutions towards a peaceful solution, reflecting the ineffectiveness, failure, and incapability of the international system in resolving and maintaining international peace and security;

**Bearing in mind** that the worsening situation in Palestine, especially in the Gaza Strip, is the result of the international community's continuous silence and selective use of a double standard policy on the relentless oppression, aggression, violence and intimidation against the Palestinian people and illegal annexation of Palestinian land;

**Affirming** that the road to peace, stability and prosperity in the Middle East comes first by ending the Zionist entity occupation of Palestine in implementation of the relevant resolutions of international legitimacy, and not to replace the political solution with economic solution through economic conferences aimed at legitimizing the Palestinian lands occupation and coexistence, and prolongs the occupation tenure.

*Emphasizing* that the practice of worship, prayers and all Islamic religious rituals in Al-Aqsa Mosque is a natural and guaranteed right for only Muslims. The Zionist entity occupation has no right to

intimidate and prevent them from carrying out their duties, while Zionist entity occupation allows settlers and extremists to break into the sanctity of Islamic sacred places, especially Al-Aqsa Mosque.

**Alarmed by** the persistent and continuous attack to health facility and personnel as well as humanitarian officers which have left the Gaza Strip's health system severely under-resourced and **regretting** the surge in violence in Gaza since 7 October, 2023 and loss of all civilian lives;

**Condemning** the genocide massacres committed by Zionist entity, airstrikes and bombardment targeting the already occupied and oppressed people of Gaza, inhuman blockade, and restrictions on humanitarian and relief assistance, which have resulted in loss of thousands of precious civilian lives including women and children, and inflicted unprecedented misery on the population of Gaza.

*Expressing concern* at the serious risks posed by the Zionist entity actions to the peace and security in the region.

- 1. Urge all Members of the APA to support and treat the State of Palestine as a full member of the United Nations.
- **2. Also urge** the international community to put pressure on Zionist Entity to stop its military aggression against the people of Gaza Strip by way of a complete ceasefire;
- **3. Demand** all countries to use their influence to urge Zionist Entity to stop and refrain from taking actions that violate human rights, as well as to lift the total blockade of Gaza;
- **4. Call** upon the United Nations and its relevant bodies to act immediately to protect Palestinian civilians, including by lifting the humanitarian aid blockade of the Gaza Strip;
- **5. Condemn**, in the strongest terms possible, the killing and targeting of innocent Palestinian civilians by the Zionist Entity military machine as well as all its acts contrary to international law and Humanitarian law, **stress** the need to force the Zionist occupying entity to fulfill all its obligations under international humanitarian law to ensure the protection of the Palestinian civilians and to stop its ongoing brutal military aggression in Palestine, especially in the Gaza Strip.
- **6. Call for** the immediate cessation of the barbaric aggression of the Zionist Entity occupation forces against the Palestine people and the immediate lifting of the siege imposed to the Gaza Strip.
- **7. Request** the Secretary General to consider the possibility of forming a political-technical body consisting of APA Member Parliaments and relevant high profile experts from their respective countries to assess the humanitarian damages caused to the Palestinian territories under the recent military attack of the Zionist Entity and to

- report to the upcoming session of the Standing Committee on Political Affairs in cooperation with Palestinian State and United Nations
- **8. Request** also the Secretary General to discuss with the APA Member Parliaments, other international and regional organizations and specialized legal institutions the issue of documentation of the crimes of the Zionist Entity, especially its recent crimes committed in the Gaza Strip, for later use in the lawsuits brought before the international courts and to report to the next session of the Standing Committee on Political Affairs in this regard.
- **9. Expresses** grave concern at the latest escalation of violence since the 7th of October and the grave deterioration of the situation in Gaza and the rest of the Occupied Palestinian Territory, including East Jerusalem, and condemns attacks targeting civilians.
- 10. Reject and strongly condemn the statements made by the Zionist Entity Prime Minister on 10<sup>th</sup> of September 2019, in which he announced his intention to annex the entire Palestinian Jordan Valley, the northern Dead Sea and settlements in the Occupied Palestinian Territories, in a massive and flagrant violation of the rules of international law and the provisions of the Charter of the United Nations and its resolutions, particularly Security Council resolution 2334 for 2016. We call upon the United Nations to defend its resolutions that end the Zionist Entity occupation and enable the Palestinian people to self-determination on their land.
- 11. Condemn all violations of international law that threaten international peace and security, including all acts of terrorism and organized crime, and human rights violations by Zionist Entity occupying forces and settlers in Palestine, and call for international protection of the Palestinian people in accordance with General Assembly resolution A / Es-10 / L. 23 of 11 June 2018, and the relevant Geneva Conventions.
- 12. Encourage all members of the international community to take up with the pressure on Zionist Entity to immediately release all the Palestinian prisoners including the Members of the Palestinian Parliament and condemns the Zionist Entity Knesset's failure to respond to the fact-finding and investigation committees established by the Inter-Parliamentary Union on prisoners in Zionist Entity jails as evident in to International Parliamentary meetings in St. Petersburg and Geneva in March 2018, and dismantle all illegal settlements as well as the entire separating wall and put an end to confiscating Palestinian lands.
- **13. Declare** all legislative and administrative measures and actions taken by Zionist Entity, including expropriation of land and properties which tend to change the legal status of Jerusalem as invalid and bearing no legal effect on their original status.
- **14. Condemn** Zionist Entity continuation of building settlements defying applicable international law particularly Security Council resolution 2334 of December 2016;

- disregarding the legitimate rights of the Palestinian People including their right to resist and protest against foreign occupation of their lands; and hampering international efforts towards achieving a just and lasting peace in the region;
- **15. Express** grave concerns on the suppression and injustice, as well as continuing violence practiced against the Palestinian people, particularly women and children, in the occupied Palestinian territories under the Zionist Entity occupation including East Jerusalem, and in the Syrian Golan occupied by Zionist Entity;
- **16.** Call Upon Countries, who are party to the Rome Statute, to impartially and fully abide by the decision of the ICC including in the context of taking an appropriate action to implement the warrants of arrest to Benjamin Netanyahu and Yoav Gallant;
- **17. Welcome the** historic decision of the International Criminal Court to issue arrest warrants against the Zionist regime Prime Minister and Minister of Defense and call on the Parliaments of Member States of the Asian Parliamentary Assembly to support this decision and participate in strengthening international efforts to hold those responsible for crimes against humanity accountable. We also stress the importance of upholding the principle of the rule of law and promoting international justice in the face of impunity.
- 18. Call Upon all members of the APA and the United Nations as well as all regional and international organizations concerned, particularly the United Nations Security Council and the International Criminal Court to address, under the UN Charter and the Rome Statute, the crimes against humanity and the war crimes committed by Zionist Entity in Palestine which threaten the international peace and security;
- **19. Condemn** the closure of the PLO diplomatic mission in Washington in retaliation for the membership of Palestine to the International Criminal Court;
- **20. Praise** the decision taken by the European Union not to purchase any products produced in the settlements based in the occupied territories and call on states of the APA Member Parliaments to act in a similar way and affirm the full support for international boycott movement against Zionist Entity occupation;
- 21. Reject the occupation policies and measures contrary to international law and the international legitimacy resolutions practiced by the Zionist entity to change the historical, cultural, religious and demographic features of the Occupied Palestinian Territory, especially the city of Jerusalem and its Islamic and Christian sanctities in general, and Al-Aqsa Mosque in particular, and also reject the Knesset law aimed at splitting the Al-Aqsa Mosque temporally and spatially; This constitutes a blatant attack on the freedom of worship and the practice of religious rites, as stipulated in human rights charters, and the First Geneva Protocol of 1977, Article 53 of which prohibits hostilities directed against places of worship.
- 22. Reject the illegal decisions taken by the Zionist Entity Knesset, such as the

Judaization of Jerusalem, the Law of Loyalty to Citizenship, the Denial of the Palestinian State and the rights of the Palestinian people in the Occupied Territories, the Law of Jewish Nationalism, and / withholding the Financing of the State of Palestine, and the theft of clearing funds that belong to the State of Palestine under the pretext of Palestinian caring for the families of the martyrs and wounded and the families of prisoners and detainees, who are victims of the occupation, in violation of Articles 89 and 98 of the Geneva Convention.

- 23. Reject and condemn the US Administration's decision to suspend its financial contributions to UNRWA, and all attempts, resolutions and alternatives that affect the status and role of UNRWA established by UN Resolution 302 of 1949. We call on all countries in the world, especially the members of this Assembly, to support and protect UNRWA's budget so that it can fulfill its obligations to about 6 million Palestinian refugees until their case is resolved in accordance with UN Resolution 194.
- **24.** Call upon the international community to fulfill its pledges to rebuild infrastructure and rehabilitate people in Gaza, which have been destroyed by Zionist Entity forces, and to support the Palestinian economy in the occupied Palestine.
- **25. Express** its full support for the inalienable rights of the Palestinian people to struggle for self-determination and to establish the independent state of Palestine with Al-Ghods as its capital and the right of return of the refugees who were displaced from Palestine in 1948 in accordance with the UN General Assembly Resolution 194.
- 26. Call upon countries that have established embassies, offices or diplomatic missions in occupied Jerusalem, to draw back the decisions in compliance with the UN Security Council resolutions referred to in the preamble to the resolution, in particular resolution 478 of August 1980, and UN General Assembly Resolution: A / ES-10 / L. 22 of December 2017, which considered the recognition of Jerusalem as Zionist Entity capital as null and void, and calling on all APA member states to refrain from establishing diplomatic missions in occupied Jerusalem.
- 27. Affirm that development, investment and improvement of the standard of living are rights denied to the Palestinian people for 75 years now, due to the continuation of the Zionist Entity occupation. It's a must first to end the occupation, in order to liberate the Palestinian economy, and enable the Palestinian people to control their natural resources and economic wealth, and invest to live a decent life away from blackmail and bargaining.
- **28. Reaffirm** its rejection of US Secretary of State declaration on 18th of Nov 2019 that Zionist Entity settlement in the Occupied Palestinian Territories is not inconsistent with the international law and considers the declaration a flagrant violation of international law and UN resolutions in particular UN Security Council resolution 2334.

- **29. Invite** the United Nations High Commissioner for Human Rights to expedite the publication of the "Black List" of Zionist Entity and foreign companies dealing and/or working in Zionist Entity settlements in the Occupied Palestinian Territories as a necessary step to isolate settlements and protect human rights.
- **30. Strongly Condemn** the recent Zionist Entity attacks on the Gaza Strip, the killing and displacement of Palestinians, and the targeting of women and children, and call for the necessity for the international community to act urgently to stop the occupation's repeated attacks against civilians, and the flagrant violation of the rules of International Humanitarian Law.
- **31. Affirm** the legitimacy of the inalienable rights of the Palestinian people, the legitimacy of the Palestinian struggle under occupation, and that the struggle of the Palestinian people is a legitimate struggle due to the existence of the occupation.
- **32. Encourage** the member parliaments of the Asian Parliamentary Assembly to take political initiatives and adopt positions that support the legitimacy of the Palestinian cause and the legitimate struggle of the Palestinian people, including abstaining from treaty relations with, entering into economic relations or trade dealings with, and in the establishment and maintenance of diplomatic missions in Zionist Entity as mandated by the UNGA resolution A/ES-10/L.31/Rev.1 adopted in September 2024.
- **33. Strongly Condemn** the calls for forced displacement of the Palestinian people from Gaza and the continued targeting of defenseless civilians to implement this plan that aims to liquidate the Palestinian cause and affirm the legitimate right of the Palestinian people to establish their independent, sovereign state on the Palestinian territories with the borders of June 4, 1967, in accordance with international legitimacy resolutions.<sup>2</sup>
- **34. Encourage** the international community to be more objective and fairer in assessing the situation in Palestine, and refrain from resorting to double standards and hypocritical views
- **35.** Call for a thorough reform of international systems, particularly the United Nations and its Security Council, in order to strengthen their role in preventing and resolving all conflicts, including in Palestine.
- **36. Further condemn in strongest terms** the blatant targeting by Zionist Entity brutal occupation forces of Al-Ahli Baptist Hospital in Gaza Strip, which killed and injured hundreds of innocent sick, injured and displaced innocent civilians, in stark violation of the international humanitarian law.
- **37.** Call on Zionist Entity to immediately halt its barbaric aggression and allow UN and other humanitarian agencies to immediately provide humanitarian and relief

- assistance to the people of Gaza.
- **38.** Calls upon member parliaments to take a serious regional and international stance in the face of this dangerous escalation by Zionist Entity and the barbaric, unprecedented bombardment to which civilians in the Gaza Strip are facing.
- **39. Affirm** its rejection of the double standard policy, which grants Zionist Entity an unconditional green light and an unrestricted license to kill whilst disregarding any opposing opinion.
- **40. Call** for an immediate, durable and sustained humanitarian ceasefire leading to a cessation of hostilities, demands that all parties immediately and fully comply with their obligations under international law, including international humanitarian law and international human rights law, particularly in regard to the protection of civilians and civilian objects, also demands the immediate, continuous, sufficient and unhindered provision of essential goods and services to civilians throughout the Gaza Strip,
- **41. Reaffirm** that the only solution to the issue of Palestine is the recognition of the Palestinian People's rights to self-determination and the establishment of a Palatine state on the historical land of Palestine.
- **42. Urge** APA Members to support media campaign that aimed to increase the awarenesses of Palestinian people rights with focusing on Zionist Entity desecrations against innocent people, in particular women and children
- **43. Support** legal international resolutions, in particular the resolution of International Court of Justice related to illegal Zionist Entity presents in Palestinian Land,
- **44. Appreciating** South Africa legal efforts of submitting the lawsuit to the International Court of Justice against Zionist Entity for its genocide massacre in Gaza,
  - 45. Strongly Condemn the recent Zionist regime attacks on the Gaza Strip, the killing and displacement of Palestinians, and the targeting of women and children, and call for the necessity for the international community to act urgently to stop the occupation's repeated attacks against civilians, and the flagrant violation of the rules of International Humanitarian Law,
  - **46. Affirm** the legitimacy of the inalienable rights of the Palestinian people, the legitimacy of the Palestinian struggle under occupation, and that the struggle of the Palestinian people is a legitimate struggle due to the existence of the occupation,

- **51. Stop** normalization of relations with Zionist Entity, following the suit of the Iraqi parliament,
- **52. Put** pressure on Zionist Entity to release the confiscated monies and possessions of the Palestinians Authority,
- **Denounce** the discrimination policy exercised by the Zionist Entity against the Palestinian people in the Palestinian territories occupied in 1984,
- **54. Refer** to the destruction of entire Gaza hospitals and not restrict that not the private hospitals,

### Draft Resolution on Enhancing Cooperation among the Members of the Asian Parliamentary Assembly to Protect and Promote Multilateralism

We, the Members of the Asian Parliamentary Assembly,

**Recalling** the relevant principles set forth in the Charter of the Assembly and the Charter of the United Nations;

*Mindful* of the existence of mutual interests and common problems among the Member Parliaments and *convinced* of the need to further strengthen the existing cooperation;

**Recognizing** the serious danger and threats posed by the actions and measures which seek to undermine international law and international legal instruments;

**Recalling** paragraph 4 of the report of Secretary-General of the United Nations entitled "Report of the Secretary-General on the work of the Organization" contained in document A/72/1 wherein it states that "now more than ever, multilateral action is needed to find effective solutions to this mix of challenges". *Sharing* his concern expressed in paragraph 140 of the same report that "multilateralism is being questioned at a time when we most need coherent global responses to these interconnected events";

*Underscoring* the need to strengthen cooperation between APA and other regional and international inter-parliamentary organizations and forums on matters related to Asia;

**Expressing** opposition to all unilateral coercive measures, with certain destructive effects on the foundation of multilateralism, including those measures used as tools for imposition of unjust political or economic and financial pressure against any country;

**Continuing** to maintain, strengthen and manifest the unity and solidarity among the members of APA, particularly with those whose nations are suffering from the negative consequences of unilateral coercive measures at political, cultural and economic levels;

**Reaffirming** that each State has full sovereignty over the totality of its wealth, natural resources and economic activity, exercising it freely;

*Gravely concerned* that the use of unilateral coercive economic measures adversely affects the economies and the development efforts of all nations, and have a serious general negative impact on international economic cooperation and on worldwide efforts to move towards a non-discriminatory and open multilateral trading system;

**Determined**, for the sake of peace and stability and promoting friendly and mutually beneficial relations among all nations in the world through, including, contribution to international cooperation aimed at strengthening multilateralism and curbing the negative effects of unilateralism, we, the Member Parliaments of APA, *agree* to undertake the following measures, among others;

*We therefore,* 

- **1. Reaffirm** our commitment to the Charter of the United Nations and universally recognized norms and principles of international law and the objectives and principles enshrined in the Charter of the Asian Parliamentary Assembly;
- **2. Reaffirm** our commitment to effective multilateralism with the United Nations at its center;
- **3.** Assert on behalf of the parliamentarian community of Asia to work in line with the expectation that the world will become more committed to promote multilateralism in all aspects of world affairs;

- **4.** *Call upon* all Parliamentarians in Asia to redouble their efforts at all possible levels to adopt measures aimed at preventing and curbing the negative effects of illegal unilateral measures undermining free, open and transparent relations among members of the Asian community;
- **5.** Call on developing countries to actively participate in promoting the principle of multilateralism in order to accelerate the world peace process, which requires enhanced forms of cooperation and multilateral governance based on international law;
- **6.** *Welcome* all initiatives of the Member Parliaments to promote and strengthen cooperation in various fields including economy, finance, transport and trade within the geography of APA at bilateral and multilateral levels;
- **7. Reaffirm** the willingness of the Asian parliamentarians to closely cooperate and collaborate with other branches of their respective governments in formulating proper and effective national plans to help promote multilateral cooperation in all spheres of regional and international relations;
- **8.** *Reject* unilateral coercive measures with all their extraterritorial effects as tools for political and economic pressure against any country in particular against developing countries;
- **9.** *Underscore* the need for all states to avoid politicization of the UN Security Council sanctions regime;
- 10. *Urge* all Member Parliaments to facilitate the adoption of urgent and effective measures to impede the use of unilateral coercive measures against any country that are inconsistent with the principles of international law as set forth in the Charter of the United Nations and that contravene the basic principles of the multilateral trading system;
- **11.** *Request* States applying these measures or laws to revoke them fully and immediately;
- 12. Reiterate unwavering support to JCPOA, which remains a significant achievement of multilateral diplomacy endorsed unanimously by the UN Security Council through Resolution 2231 dated 2015 and underscore that JCPOA proved to be effective and has no alternative and welcome the full implementation by Iran of its nuclear-related commitments, as repeatedly confirmed by the IAEA, and call upon all other parties to fulfill in total their own obligations stemming from JCPOA and the UNSCR 2231 so that overarching goals which induced the conclusion of the accord are achieved in due course and in a timely fashion;
- **13.** *Reaffirm* sovereign right of our people to acquire, manufacture, export, import and retain all economic goods required to ensure an acceptable standard of living and a

- sustainable development for them, and *emphasizes* that no undue restrictive measure should be taken against any country in this regard;
- **14.** *Emphasize* that under no circumstances should people be deprived of their own means of subsistence and development and stress that no illegal restrictive measures should be taken against any Member State in this regard;
- **15.** *Reiterate* that food and basic goods should not be used as an instrument for unilateral political and economic pressure. *Stress* the importance of international cooperation and solidarity, especially within the framework of APA, to prevent such unilateral coercive measures that affect the trade related to food and basic goods and would endanger food security impacting specially groups in vulnerable situations;
- **16.** *Request* the Secretary-General to submit a report to the next meeting of the Standing Committee on Political Affairs containing initiatives, including those introduce by the Member Parliaments, to promote the role of parliamentarians, especially within the framework of APA, in furthering multilateralism;

# Report of the APA Working Group on Statutory Documents (Alongside the APA Standing Committee Meeting) Baghdad- Republic of Iraq

January 11, 2025

The APA Working Group on Statutory Documents was held on 11 January 2025 on the sidelines of the Standing Committee Meeting on Political Affairs in Baghdad, Republic of Iraq, and chaired by Mr. Al-Kinani, Head of Delegation of the Council of Representatives of Iraq.

Participants of the Standing Committee Meeting on Political Affairs attended this Working Group Session.

After adoption of the attached agenda and a brief summary addressed by the APA Secretary General, the attached non-paper on updated version of Article 5 of the APA Charter and Rule 15 of the Rules of Procedure were presented by the APA Secretary General.

Participants debated and exchanged views on the contents of this non-paper and agreed that:

- There should only be four Standing Committees. Any other issue to be addressed should be considered within the scope of sub-committees which will directly report to the relevant Standing Committees.
- Representative of the APA Secretariat clarified that the issue which was agreed by this Working Group will be reported to the Executive Council for its review and final approval.

## **Non-Paper WG on Statutory Documents**

( **January 2025**)

The following text is proposed to replace Article 5 of the APA Charter and Rule 15 of the APA Rules of Procedure: (Proposed by APA Secretariat) amended by Russian Delegation.

## **Basic Organs and Structure**

Article 5-A: Basic Orders of APA Organs,

The APA Shall be composed of the Plenary, the Executive Council, the Bureau of the Assembly, the Standing Committees and the Secretariat,

Activities of the APA Organs and establishment of subsidiary bodies shall be regulated by the Rules of Procedure of the APA,

Article 5 B: Organizational Structure of the APA,

The organization of the hierarchy structure shall be arranged in a democratic manner indicating clearly the specific composition, function, powers and rules of procedure of each organ, to reach balance, harmomy and effectiveness of the APA work, as an institution, all, subject to the approval of the Plenary

## IV. Standing Committees and Sub-committees:

#### **Rule 15:**

- 1. The Plenary may set up Standing Committees and Sub-Committees as deemed necessary to deal with any subject of interest and to examine the issues on its agenda. These bodies shall submit as appropriate their draft resolutions, reports and recommendations to the Plenary for its consideration and decision.
- 2. The APA shall have four Standing Committees on: Political Affairs, Economic and Sustainable Development, Social and Cultural Affairs, Budget and Planning.
- 3. Upon suggestion of the Bureau or at least ten Member Parliaments, establishment of Sub-Committees, shall be put on the agenda of the Executive Council.

- The recommendation of the Executiv Council on this issue is approved by the majority vote of the delegates present and voting in the Plenary.
- 4. The inter-sessional meeting of sub-committees shall be convened by the Member Parliament hosting the previous Plenary, unless following mutual agreement of the President and the Permanent Secretariat, may be hosted by another Member Parliament.
- 5. Number of membership of each Sub-Committee, taking into account the equitable geoographical distribution, and the duration and number of their inter-sessional meeting shall be approved by the Plenary

## The 2nd APA Meeting on Palestine Committee (Baghdad Republic of Iraq) January 11, January 2025

Remarks by H.E. Dr. Mohammad Reza Majidi Secretary General of the Asian Parliamentary Assembly

Mr. Chairperson, Distinguished delegates, Ladies and Gentlemen

At the outset, I deem it necessary to extend my heartfelt appreciation to all my Iraqi brothers who have shouldered the burden of organizing the SC Committee Meeting on Political Affairs and at the same for their commendable initiative deciding to hold the 2<sup>nd</sup> APA Meeting on Palestine Committee at this crucial moment.

Secondly, I would like to thank all those colleagues in the APA who initially raised the idea for the establishment of this Committee and those who shared this idea and made all necessary cooperation at the APA meetings for adoption of the decision to establish this Committee within the framework of APA.

As you may recall, the first meeting of the Asian Parliamentary Assembly Committee on Palestine was held on January 10, 2024 in Tehran, the capital of the Islamic Republic of Iran. Eighteen Parliamentary delegations from APA member countries participated in the meeting and the "Final Communique on the turbulent Situation in Palestine" was considered and adopted unanimously.

#### Dear Colleagues,

The year 2024, besides its usual ups and downs, was a very tragic year for the Palestinian people in the Gaza Strip and across the world. Crime against humanity and act of genocide reached its climax in the aftermath of the ongoing atrocities perpetuated by the Apartheid regime of Israel in the blockaded enclave. Though other parts of the world were not immune from war and bloodshed, but magnitude of the horrendous brutalities, crimes and extreme devastation of the infrastructures in the Gaza Strip were glaring proofs to the fact that there smees no hope can be placed on the more serious cooperation on the part of international community to bring the humanitarian crisis unfolded in the region. The situation that prevails

in the occupied Palestine today is both a clear example of regional and international insecurity and a clear manifestation of crime and genocide.

While humanitarian crisis should be center of every regional and international forum it is extremely deplorable to witness that silence and inaction of the International Community against such an extensive dimension of Zionist regime's atrocities, has given this regime a free hand to aggravate its unhindered act of terror not only in Gaza, but also in other parts one after the other, including Lebanon and Syria. What is happening in this war-torn enclave is but embodiment of war crimes and genocide. It is incredible that the world continues to remain silence and does not take a practical measure to put an end to this human tragedy.

The long-lasting issue of Palestine which testifies to nearly 8 decades of occupation of an ancient land and the displacement of the majority of its native inhabitants followed by the suppression of the remaining population in Gaza, is not merely a Palestinian–Israeli issue. This decades-long disaster facing Palestine and its people is the issue of humanity and the entire international community

Under such circumstances, when the Apartheid regime of Israel has resorted to every possible means to continue its act of genocide incessantly targeting schools, hospitals and other sensitive areas, APA in the context of its mandate as representative of the people within the vast Continent of Asia has spared no effort to galvanize its full-fledged support to alleviate suffering of the Palestinians under siege in the Gaza Strip through channels of parliamentary diplomacy since its establishment in 2007. In fact, establishment of this Committee is a seminal decision intended to reaffirms APA's steadfast commitment and unwavering support for the Palestinian people in their endeavor to establish an independent state with Al-Quds as its capital and to see how it would be able to find a solution with the help of APA member parliaments in the context of multilateral parliamentary cooperation.

In conclusion, it is my fervent hope that parliaments and parliamentary forums across the world composed of lawmakers representing people can close their ranks and take a unified decision with due respect to the critical situation in Gaza, Lebanon and Syria and give impetus to parliamentary diplomacy in an attempt to ensure democratic voices as part of their mandate for giving an end to the humanitarian crisis in the region.

# Separate Opinion of the Russian Delegation on the APA Draft Resolution on Asian Parliaments' Unwavering Support for the Palestinian People (Baghdad, January 11-12, 2025)

The Russian delegation to the Asian Parliamentary Assembly wishes to express its respect for the delegations of all member countries of the Assembly and would like to voice the following regarding the Draft Resolution on Asian Parliaments' Unwavering Support for the Palestinian People.

We extend our heartfelt condolences to the families and friends of those who have lost their lives as a result of armed confrontations and empathise with all those who have suffered. We hope that humanitarian situation in the crisis zone will recover. Any violence against civilians is unacceptable, including strikes against civilian infrastructure, medical facilities, and places where the elderly, women, and children gather.

Russia's position on the Palestinian-Israeli conflict and the pathways towards establishing lasting peace in the region is well-known and consistent. It is essential, above all, to achieve an immediate and comprehensive ceasefire, as well as a humanitarian truce to provide assistance to all those in need. We endorse the core mandate of UNRWA as a unique agency for aiding Palestinians. We acknowledge the importance of de-escalating hostilities and renouncing violence.

We advocate for the full resumption of the political and diplomatic process aimed at achieving a long-term and fair settlement to the inveterate Middle Eastern conflict following internationally recognised legal principles, including, in particular, the UN Security Council resolutions. The ultimate outcome of this process should be the establishment of an independent Palestinian state within the 1967 borders, with East Jerusalem as its capital, coexisting in peace and security with Israel. It is the only approach that will help achieve a sustainable solution and break the vicious circle of bloodshed.

We welcome the UN General Assembly Resolution on the admission of Palestine as a full member to the United Nations adopted in May 2024 by the overwhelming majority.

Hence, the Russian delegation, while generally supporting the spirit of the APA Draft Resolution on Asian Parliaments' Unwavering Support for the Palestinian People, deems it necessary to use the terminology and wordings enshrined in the resolutions of the UN Security Council and General Assembly that correspond to the high level of activity of the Asian Parliamentary Assembly.

We are convinced of the need to further enhance inter-parliamentary cooperation at the Asian Parliamentary Assembly to put an end to the suffering of the people of Gaza and to promote the use of peaceful political and diplomatic means that lead toward a comprehensive resolution of the Palestinian-Israeli conflict and, more broadly, the Middle Eastern conflict, whose escalation has brought destabilisation to the entire region.
