### 6. Request of the Asian-African Parliamentary Council (AAPC) for APA observer status

The Asian-African Parliamentary Council (AAPC) on 20 October 2025 officially requested for APA observer status. Participants are requested to address this issue for its final approval by the Plenary.

## 7. Consideration of Draft Resolutions of Standing Committees on:

- **Economic and Sustainable Development**

The Standing Committee on Economic and Sustainable Development was held on 14-16 September 2025 in Manama, Kingdom of Bahrain. The committee considered and adopted 3 draft resolutions on its Agenda. The remaining draft resolutions are to be considered in the next Standing Committee meeting.

- **Social and Cultural Affairs**

The Standing Committee on Social and Cultural Affairs during its meeting on 28-30 October 2025 in Moscow, Russian Federation, adopted 14 draft resolution. The Committee requested the delegation of Azerbaijan as sponsor, of the draft resolution on "Commission on Women" to introduce a new version of this draft resolution, with a view to reaching consensus on the content of it.

- **Political Affairs**

The Standing Committee on political Affairs took place on 4-5 December 2025 in Mashhad, Islamic Republic of Iran. The Committee adopted all 8 draft resolutions.

- **Budget and Planning**

The standing Committee on Budget and Planning during its meeting on 24-28 December 2025 in Doha, State of Qatar, considered the Draft Resolution on APA Budget & Planning with some modification.

**Note:** In the meeting of Executive Council only minor/typographical corrections to draft resolutions are allowed (i.e. APA/Decision/2016/01). Major amendments to such documents will be considered during the meeting of standing Committee
